FOR RIGHT OF OPERATION OF MOBILE GAME “DAWN AWAKENING”  
(ORIGINAL NAME: DAYBREAK LEGENDS) IN HONG KONG, MACAU AND TAIWAN**

This announcement is made voluntarily by Gameone Holdings Limited (the “**Company**”) and does not constitute a transaction discloseable under Chapters 19 and 20 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited. The Company (together with its subsidiaries, the “**Group**”) is pleased to announce that Gameone Group Limited (a wholly-owned subsidiary of the Company, “**Gameone HK**”) has entered into a cooperation agreement with Linekong Interactive Group Co., Ltd. (the “**Linekong Interactive**”) (Stock Code: 8267) on 22 January 2021, to obtain the right of operation of *Dawn Awakening* (黎明覺醒) in Hong Kong, Macau and Taiwan by Gameone HK. The game is expected to be launched in the first quarter of 2021. To the best of the knowledge, information and belief of the directors of the Company (the “**Directors**”), Linekong Interactive and its ultimate beneficial owner(s) are independent of and not connected with the Company and its connected persons.

*Dawn Awakening* is a remake version of *Daybreak Legends* (黎明之光) with optimization and data adjustments. *Daybreak Legends* is known as the 3D magical adventure mobile game of the People’s Republic of China.

The story of *Dawn Awakening* takes place on the Loya Land\* (洛亞大陸), a century-old battlefield for the war between humans and demons. The combat method combines the main elements of action role-playing games and shooting games, including swords, guns and bows and magic etc. Players can make commands, such as takedown, combo, knock off and circling dodge to perform magnificent and powerful attacks and actions.
